#### Message to GB:

The house tells the Principal to request the GB to give their views on Best Practices which are being thought upon by the teachers. The IQAC is willing to adopt the making of Charitable Fund for the needy as Best Practice for the college as involvement in extension activities would instil sensitivity to social problems and spirit of social service in our students.

The house also desires the GB to consider if free tiffin may be given to needy students.

The IQAC is framing the questionnaire of Student Satisfaction Survey; the house requests the Principal to inform the GB that it will be required to act based on the feedback given by students. It is to be treated as very important matter.

#### Message to Departments:

The house discusses that the website needs to be updated regularly. It is resolved that the individual departments be requested to upload Activities of the Department, CU questions, Departmental Notices and Students' List on the departmental page. It is further resolved that teachers will motivate students to utilise Swayam and MOOCS.

#### Message to Cells and Committees

Each cell/ committee be requested to update and rearrange their respective pages on the official website. The page must contain an Introduction, Names of members, Meeting, Resolutions, Other Activities. Each cell/ subcommittee will arrange observation of at least One Day in a Calendar Year.

#### Miscellaneous:

The IQAC members discuss the utility of MoU already signed in 2022 that will bring scope of internship, research and employment for our students. Dr B.B. Choudhury points out that the college has signed MoU with IMS and ICA in April 2022 and September 2022 respectively. These will help to boost the employability of our students. ICA will conduct an Add On course. The members discuss the necessity of starting more such Add-On Courses. However, the lack of space and constraints of time will be a severe challenge in the way of materializing more Add-On Courses.
